Program Overview

The New York State Law Enforcement Agency Accreditation Program was established in 1989 to promote professionalism, efficiency and effectiveness in the field of law enforcement. Executive Law Article 36, §846-h created the Law Enforcement Agency Accreditation Council, the governing body responsible for establishing program standards, awarding accreditation and overseeing the direction of the program. Title 9 of the Official Compilation of Codes, Rules and Regulations of the State of New York (Part 6035) designated the New York State Division of Criminal Justice Services (DCJS) as the agency responsible for administering the program. The Accreditation Unit within the DCJS Office of Public Safety is tasked with that work.

Through the program, which is voluntary, eligible law enforcement agencies are recognized for meeting the highest standards of excellence in law enforcement. Accreditation requires that agencies develop and implement policies and procedures to comply with the program's 133 standards: 69 related to agency administration, 52 to operations and 12 to training.

Law enforcement executives who elect to have their agencies participate in the program must submit an application indicating their intent to work toward accreditation as well as a participation agreement outlining the responsibilities of the agency, the Council and DCJS. Agency staff then work to develop policies and procedures that are aligned with program standards. Agencies typically spend between six to 24 months preparing for accreditation, depending on the amount of staff time devoted to the project and the number of policies that must be revised and/or developed.

Once an agency has completed the steps necessary for accreditation, an assessment is conducted to determine if the agency has complied with all of the program standards. A team of three assessors spend three days at an agency, reviewing the agency's program files, conducting interviews and observing the agency's compliance with the program standards. If the assessment team determines that the agency has demonstrated compliance with all of the program standards, they submit a recommendation to the Council that the agency be awarded accreditation.

The Council awards certificates of accreditation to agencies that meet or exceed all of the established standards as determined through the assessment process. Agencies are accredited for five years, during which they must maintain compliance with all program standards. Each year, accredited agencies submit an Annual Compliance Survey, which is a progress report intended to ensure that any lapses in compliance are immediately identified and fixed. In addition, Accreditation Unit staff conducts site visits to ensure compliance is being maintained. Agencies that apply for reaccreditation must undergo an assessment about three months before their five-year period of accreditation is due to expire. If successful, the agency is reaccredited for another five years.

The Law Enforcement Agency Accreditation Council

The Law Enforcement Agency Accreditation Council is the governing body for the program, establishing program standards and adopting policies that determine how the program is administered. The Council has the exclusive authority to award accreditation to an agency.

Executive Law §846-h, subsection 2 (a) (i) through (xii), details who may be appointed to the 17-member Council. Council members are nominated by the New York State Association of Chiefs of Police (3 seats); New York State Sheriffs' Association (3); the Deputy Sheriffs' Association (1); police labor organizations (2); Association of Towns (1); Conference of Mayors (1); Association of Counties (1); the New York State Senate and Assembly (1 each); and the academic community (1). The superintendent of the New York State Police and commissioner of the New York City Police Department are ex-officio members of the Council. The Governor appoints all Council members, with the exception of the two ex-officio members.

At the beginning of 2015, 14 of the 17 Council seats were filled. By the end of the year, the Council lost four members, leaving the Council with seven vacancies: two appointments by the Chiefs' Association; one by the Sheriffs' Association; one by the Deputy Sheriffs' Association; one by the Conference of Mayors; one by the Association of Counties; and one by the state Assembly.

Efforts are underway to fill these vacancies to ensure that the Council is adequately represented by all appropriate stakeholders.

DCJS Office of Public Safety

Staff members of the Office of Public Safety's Accreditation Unit administer the day-to-day activities of the program in accordance with the policies set forth by the Council. They also assist staff of agencies participating in the program. The Accreditation Unit has the following responsibilities:

Support for the Law Enforcement Agency Accreditation Council

- Accreditation Unit staff members provide all professional and administrative support to the Council. They coordinate quarterly Council meetings, compile information relevant to matters before the Council and keep Council members informed about updates or potential issues with regard to the program. Unit staff members also review Council policies for accuracy and relevance; revise those policies when necessary and draft new policies based on program needs.
- The Unit is responsible for ensuring Council meetings follow all Open Meetings laws, including publicizing notice of the meetings; video recording meetings and making them available to the public; and preparing and distributing minutes of the meetings in a timely manner.

Support for Agencies

- The Unit offers assistance and support to agencies pursuing or maintaining accreditation by providing information about the program, interpreting the intent of standards, assisting with program development, offering feedback on policies developed by agencies and providing guidance on how agencies can best demonstrate compliance with the standards. Staff members assist agencies in overcoming obstacles to becoming accredited and work with already accredited agencies to ensure ongoing compliance with program standards.
- The Unit also works with agency staff to determine readiness for assessment, selects the team of assessors for each assignment, handles all logistical arrangements to ensure the agency and the assessors are prepared for the on-site assessment; and coordinates training for agency program managers, command staff and program assessors. Staff members strive to provide technical assistance and support to assist every agency's efforts to either attain or maintain accreditation.

Assessors

Program assessors must apply for the positions and be approved by the Council. Assessors must demonstrate that they have had direct involvement in either the management or supervision of the accreditation program. Once approved by the Council, assessors must attend a day-long training before being considered for assignment to an assessment team. Once assigned, they receive additional on-the-job training by being partnered with the program's most experienced assessors.

Program Participation

At the end of 2015, 148 agencies were accredited, about 27 percent of the approximately 550 law enforcement agencies eligible to participate. The Appendix lists those agencies.

Those agencies employ nearly 60 percent of all police officers outside of New York City.

Accredited Agencies

In 2015, the Council awarded accreditation for the first time to six agencies at its meetings in the following months:

- March: SUNY Geneseo University Police Department



- June: Eastchester Town Police Department, Haverstraw Town Police Department, North Syracuse Village Police Department, Old Westbury Village Police Department, and Rye Brook Village Police Department

The Council also reaccredited 24 agencies:

- March: Canandaigua City Police Department, Chemung County Sheriff's Office, Delaware County Sheriff's Office, Mount Vernon City Police Department, New Castle Town Police Department, New York State Police, and White Plains Department of Public Safety
- June: Suffolk County Police Department
- September: Beacon City Police Department, Bethlehem Town Police Department, Cornwall Town Police Department, Rochester City Police Department, Scarsdale Village Police Department, Utica City Police Department, Warren County Sheriff's Office, and Waterford Town and Village Police Department
- December: Endicott Village Police Department, Genesee County Sheriff's Office, Kingston City Police Department, North Castle Town Police Department, Orange County Sheriff's Office, SUNY Stony Brook University Police Department, Troy City Police Department, and Yates County Sheriff's Office

The number of accredited agencies in New York State has increased annually since 2006.



Applicant Agencies

Another 46 agencies are working toward accreditation, with seven currently scheduled to undergo their initial assessment in 2016. The Appendix lists applicant agencies as of Dec. 31, 2015. There are a total of 194 agencies that are either accredited or actively working toward accreditation.

Withdrawn or Expired Agencies

In 2015, the Jamestown City Police Department and Hornell City Police Department voluntarily forfeited their accredited status, citing fewer resources as the reason they were unable to maintain the administrative requirements of the program. In addition, the East Syracuse Village Police Department withdrew from the program because it merged with the Dewitt Town Police Department, another accredited agency.

2015 Program Updates

Adoption of Revised Standards and Compliance Verification Manual, Eighth Edition

In 2015, the Council adopted the Law Enforcement Agency Accreditation Program's *Standards and Compliance Verification Manual, Eighth Edition*.

The adoption of the new manual culminated a lengthy process involving the review of all accreditation standards. The process began by surveying the chief law enforcement officers and program managers of accredited agencies and program assessors for input on what standards needed to be changed, clarified, deleted or added.

DCJS then formed a Standards Review Committee comprised of experienced program assessors and representatives recommended by the Chiefs' Association, Sheriffs' Association and New York State Police. Using survey results, the Standards Review Committee reviewed every accreditation standard for relevance, clarity and the potential need for new standards. The committee met six times in 2014 and 2015 and the Council discussed and approved its final recommendations in June 2015.

The Council approved a reduction in the number of standards, from 133 to 110. It added five new standards and deleted and/or consolidated 28 standards to eliminate redundancy. Six standards related to evidence and property management and personnel matters underwent significant revisions while others had only minor revisions – mainly for clarification – to language, commentary and/or compliance verification strategies.

Accredited agencies must comply with the new standards by June 1, 2016.

Site Visits

The Accreditation Unit began conducting site visits to accredited agencies in January 2015 based upon a recommendation made by the DCJS Office of Internal Audit and Compliance and a subsequent Council policy requiring a minimum of one site visit during each agency's five-year accreditation period.

Unit staff members implemented a procedure to ensure consistency and equality in the process. Site visits have allowed them to identify agencies facing challenges with maintaining compliance with standards and to work with those agencies to develop corrective action plans. This work has resulted in an enhanced level of technical assistance to accredited agencies. It is anticipated that these additional site visits will allow agencies to identify compliance issues and address them so they are better positioned for reaccreditation.

Training

In 2015, the Accreditation Unit offered training to approximately 90 program managers, chiefs of police, command staff and other agency staff in Nassau, Onondaga, and Dutchess counties. In addition, about 100 agency participants attended two live meetings that detailed changes to accreditation standards.

Upcoming Initiatives

In 2016, the Accreditation Unit is scheduled to:

- Coordinate assessments for 28 accredited agencies due to expire in 2016. Eight additional agencies are scheduled to be assessed for their initial accreditation.
- Provide technical assistance to accredited agencies working on the conversion to the Standards and Compliance Verification Manual, Eight Edition. Accredited agencies must have their programs and files converted by June 1, 2016 or Sept. 1, 2016 (for agencies undergoing assessments prior to June 1, 2016).
- Offer at least one program manager and one assessor training during the year. In addition, developing a training course to assist agencies with maintaining accreditation continues to be a goal.

Conclusion

The New York State Law Enforcement Agency Accreditation Program is a source of great pride for the more than 18,000 law enforcement professionals that are employed by accredited law enforcement agencies.

The Law Enforcement Agency Accreditation Council and DCJS remain committed to the integrity and longevity of the program through continuous evaluation and enhancement to ensure that it meets the ever-changing needs of law enforcement professionals throughout New York State.
